

# HANDBOOK FOR CODE OF CONDUCT AND PROFESSIONAL ETHICS

Melamora College Melamora, Golaghat, Assam, Pin-78702

#### Code of conduct:

The code of conduct for students, teachers and non teaching staff is characterised by integrity. Melamora college has set the following code of conduct.

#### For students:

- 1. Regularity and punctuality.
- 2. Every student must carry his/her I card
- 3. Student must help to keep the institution campus neat and clean.
- 4. Student must wear institute uniform.
- 5. Students are expected read notice/circular displayed on the notice board and website.
- 6. Spitting, smoking and throwing nits of papers must be avoided.
- 7. Violations of these will be considered as punishable crime.

#### For teachers:

- 1. All faculty members must maintain high standard of punctuality, honesty and professional ethics.
- 2. Every faculty member shall discharge his/her duties efficiently and effectively as per the norms laid down by the authority.
- 3. Every faculty member shall respect the rights and dignities of the students in expressing his/her views.
- 4. Maintenance of impartiality.
- 5. Responsible for regular classes and extra curricular activities.
- 6. Must be socially responsible.

#### For non teaching staff:

- 1. Discharge of duties timely, efficiently and deligently.
- 2. Maintaining professional ethics.
- 3. Keeping appropriate level of confidence regarding the maintenance of records.
- 4. Must be co operative to the students, colleagues and faculties.

#### **PROFESSIONAL ETHICS**

#### Introduction

Professional ethics are personal and corporate rules that govern behavior with the context of a particular profession. As prescribed by UGC the professional ethics for teaching profession is as follows:

#### TEACHERS AND THEIR RESPONSIBILITIES

A teacher is constantly under the scrutiny of his students and society at large. Therefore every teacher should see that there is no incompatibility between his precepts and practice. The national ideals of education which have already been set forth and which he/she should seek to inculcate among the students must be his/ her own ideals. The profession further requires that the teachers should be calm, patient and communicative by temperament amiable in disposition.

#### Teachers should:

- Adhere to responsible pattern of conduct and demeanor expected of them by community.
- Manage their private affairs in a manner consistent with dignity of profession.
- Seek to make professional growth continuous through study and research.
- Express free and frank opinion by participation in professional meetings, seminars, conferences towards contribution of knowledge.
- Maintain active membership of professional organizations and strive to improve education and profession through them.
- Perform their duties in form of teaching, tutorial, practical, seminar and research work conscientiously and with dedication.
- Cooperate and assist in carrying out functions relating to educational responsibilities
  of the college and the university such as assisting in appraising applications for
  admission, advising and counseling students as well as assisting the conduct of
  university and college examination including supervision, invigilation and
  evaluation.
- Participate in extension, co circular and extra circular activities including community service.

#### TEACHERS AND STUDENTS

#### **Teachers should:**

- Respect the right and dignity of the student in expressing his/ her opinion.
- Deal justly and impartially, with students regardless of their religion, caste, political, economic, social and physical characteristics.
- Recognize the difference in aptitude and capabilities among students and strive to meet their individual needs.
- Encourage the students to improve their attainments, develop their personalities and at same time contribute to community welfare.
- Inculcate among students scientific outlook and respect for physical labor and ideals of democracy, patriotism and peace.
- Be affectionate to students and not behave in a vindictive manner towards any of them for any reason.
- Pay attention to only the attainment of the student in the assessment of merit.
- Make themselves available to the students even beyond their class hours and help and guide the students without any remuneration or reward.
- Aid students to develop an understanding of our national heritage and national goals.
- Refrain from inciting students against other students, colleagues or administration.

#### TEACHERS AND COLLEAGUES

- Treat other members of the profession in the same manner as they themselves wish to be treated.
- Speak respectfully to other teachers.
- Refrain from lodging unsubstantiated allegations against colleagues to higher authorities.
- Refrain from allowing considerations of caste, creed, religion, race or sex in their professional endeavor.

#### TEACHERS AND AUTHORITIES

- Discharge their professional responsibilities according to existing rules and adhere to procedures and methods consistent with their profession in initiating steps through their own institutional bodies and professional organizations for change of any such rule detrimental to the professional interest.
- Refrain from taking any other employment and commitment including private tuitions and coaching classes which are likely to interfere with their professional responsibilities.
- Cooperate in formation of policies of the institution by accepting various offices and discharge responsibilities which offices may demand.
- Cooperate through their organization in the formulation of policies of other institutions and accept offices.
- Cooperate with authorities in betterment of the institution keeping in view the interest and in conformity with dignity of profession.
- Should adhere to conditions of contract.
- Give and expect due notice before change of position is made.
- Refrain from availing themselves of leave except on unavoidable grounds and as far as practicable with prior intimation keeping in view their particular responsibility for completion of academic schedule.

#### TEACHERS AND NON TEACHING STAFF

- Teachers should treat non teaching staff as colleagues and equal partners in a cooperative undertaking within every educational institution.
- Teachers should help in the function of joint staff councils covering both teachers and non teaching staff.

#### TEACHERS AND GUARDIAN

• Try to see through teachers bodies and organizations that institutions maintain contact with guardians, their students, send reports of their performances to the guardians whenever necessary and meet the guardians in meeting convened for the purpose of mutual exchange of ideas and for the benefit of institution.

#### TEACHERS AND SOCIETY

- Recognize that education is a public service and strive to keep the public informed of the educational programmes which are being provided.
- Work to improve education in the community and strengthen the community moral and intellectual life.
- Be aware of social problem and take part in such activities as would be conducive to progress of society and country as a whole.
- Perform duties of citizenship, participate in community activities and shoulder responsibility of public offices.
- Refrain from taking part in or subscribing to or assisting in any way activities
  which tend to promote feeling of hatred or enmity among different communities,
  religions or linguistic groups but actively work for national integration.

#### POLICY ON CODE OF CONDUCT

#### Introduction:

#### Purpose:

The college code of conduct serves to:

- Clarify the mission, values and principles of Melamora College andlink them with standards of professional conduct.
- Create a safe and structured learning environment that will promote the college's goals for learning.
- Serve as a guiding principle about ethical and professional conduct for students, teachers and non-teaching staff affiliated within the institute.

- Impartially address the requirements and grievances of all the stakeholders and provide mechanisms.
- Help prevent and detect ethical or legal violations.

#### Implementation:

Enforcement of the Code of Conduct shall be ensured through the Code of Conduct Monitoring Committee. The committee shall be responsible for:

- Identifying and incorporating the Code of Conduct for the students, teachers, librarian, administrators and other college staff in dedicated handbooks.
- Reviewing the Codes at specific intervals and reprinting the Handbooks whenever necessary.
