1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Melamora College is a pioneer co-educational institution of higher education located in a rural environment surrounded by tea garden community. Melamora College was established in 1987 representing the mass populated rural area of greater Melamora of Golaghat, Assam. It is located at a ditance of 15 k.m away from Golaghat town, 11 k.m away from N.H 37 and 25 k.m away from Dergaon town. The people of Melamora and its adjoining area with great enthusiasm and co-operation resolved to establish an institution of Higher Education at Melamora under the leadership of Late Gangadhar Saikia. The land for the College was donated by an Agarwal family known as Bhimraj-Debraj Agarwal family. The College was started at "Bhimraj-Debraj Natyamancha" and later it was shifted to its own building. The College received permission affiliation from Dibrugarh University w.e.f 31/12/1998. The College has been offering B.A. Major and Non Major programmes in Arts stream. After a long year of persistent effort and sacrifice of a group of well-wishers and dedicated teachers, non-teaching staff the College was provincialised on 14-08-2013. The College received UGC 2F recognition on 20th September 2012 under UGC ACT 1956. Presently with the guidance of present Principal, a group of dedicated teaching staff, energetic office staff the College is educating a number of pupils of this rural area under graduate level. The College is always thankful to Late Kiron Ch. Bora, Mr Romesh Saikia and all the well-wishers of this locality and the President of the Governing Body including members of this College.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

As an affiliated College, at present the College is running CBCS system in Semester mode. The curriculum of UG program under this system comprises both Major and Non-Major Subjects. There are a few common papers for all such as Environmental Studies paper, Multidisciplinary paper, Language paper, Communicative Skill paper. The Non-Major students of B.A. 5th & 6th Semester have to take Skill Based course out of courses approved by the affiliating University. The curriculum of UG program under CBCS system comprises of Major Courses in seven subjects. Besides the Major subjects, the students have to take Ability Enhancement Compulsory Courses and Generic Elective Subjects. The students have also been given flexibility to opt for the Skill Enhancement Courses from ample of subjects. The College has introduced four Add-on courses to enhance the skills of the students so that they can be able face the hard realities of life. The feedback from stakeholders also plays vital role in the introduction of any new courses. Most of curriculum followed is primarily prepared and organized by the respective Affiliating University.

Teaching-learning and Evaluation

The teaching-learning process is student-centric, more interactive and students are given opportunity to participate in the class. There is a provision of educational tours, use of library and e-resources to encourage them. There is a well-equipped central library with sufficient stoke of books and ICT is encouraged by the way of providing free internet through Wi-Fi. LCD projectors, smart class are provided for effective teaching. The College faculty adopts some innovative teaching approaches like interdisciplinary lectures, interactive session, extempore speeches on syllabi related topic etc. The examination schedule is fixed by the parent University. The College plans and conducts Sessional examination in every semester through the academic Committee. All internal examinations are conducted by the internal examination board headed by the Vice-Principal with the approval of the Principal. Besides, various departments conduct unit test and class test for continuous evaluation. The faculties participate in the evaluation process of the affiliating University. The project reports and reports of Environmental studies and skill based course are done by concerned deputed teachers.

Research, Innovations and Extension

In matters of getting research grants and projects, the College is lagging far behind. However, in the extension aspect, the College has conducted seminars, workshops, capacity building program etc. The faculties of the institution have published a number of research papers, books, chapters etc. One faculty is perusing research project. The College has carried out a good number of extension and outreach programmes at the initiative of IQAC, Women Cell, Skill Enhancement Cell etc. The participation of students in such programmes and activities is quite remarkable and encouraging. Further, the College has few collaboration and functional MOUs with nearby institutions.

Infrastructure and Learning Resources

The College has satisfactory infrastructure to make teaching-learning process effective. Spread over an area of 10 Bighas of land, the College is functioning with the grants and from Govt. of Assam,

local donor's contribution and to some extent by its own resources. The class rooms of the College are specious with facilities like electricity, black boards, smart class room interactive panels (HD) Projector system with adequate number of desks and benches. The entire College campus including class rooms under the surveillance of CCTV cameras. The College has Wi-Fi facilities for virtual connectivity. The institution has a central library with large no of books, computers, photocopy facility spacious reading hall, server and digital operating system. The College has a well-equipped auditorium cum seminar hall, which is used for various academic cultural and social programs. Apart from this, the College has NSS unit, one Boys' Hostel, playground, open stage and other facilities.

Student Support and Progression

Student related information are provided through the College website, Notice board and other social media sites of the College. The College relies on SMS and WhatsApp to disseminate information. The College provides freeship and all sorts of Govt. scholarship to the deserving students. The College has number of Cells and Committee like Skill Enhancement Cell, Career Counseling and Guidance Cell etc. to promote the students for competitive examinations. The grievance redressal Cell takes grievance and prompts steps to solve grievances. The placement of outgoing students and progression to higher education of our students are satisfactory. A few number students have participated in sports and cultural events during the assessment period. Besides, providing financial assistance to the needy students, the College extends support to the students. This in turn helps in promoting a competitive mindset among the students.

Governance, Leadership and Management

In order to materialize the vision and mission of the College, decentralization of powers and functions are emphasized. The HoDs, the co-ordinator, conveners of different cells and committees are instrumental force in formulating and implementing polices. This practice is visible in College administration. The perspective plan of the College has been prepared considering it's shorts and long term goals. The College encourages its staff and faculties to participate in seminars, workshop ,FDP, refresher course, FIP etc. constantly. The College has introduced e-governance in areas like administration and examination. The College has a transparent financial management. The Principal and Vice-Principal serve as the rules set by the financial rules of the Govt. of

Assam and UGC.

Institutional Values and Best Practices

The College organizes a number of gender equity and sensitization programmes every year to overcome gender discrimination. Safety and security measures are implemented. Anti-Sexual Harassment Cell has been working for promoting sex neutral environment. The institution has an eco-friendly campus landscaping with trees and plants. It also tries to make it a plastic free campus. It has a prescribed Code of conduct for all stakeholders. So far as the execution of it, there is a Code of conduct Committee to monitor it. To inculcate value and sense of nationalism in the minds of young students, the institution celebrates national festivals every year. It undertakes different initiatives to sensitize student to the constitutional obligation & to enable them to behave as a responsible citizen. Observation of Independence Day, Constitution Day and Voter's Day are some of the initiatives in this regard. The institution promotes many practices to achieve its mission of quality education. Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The institution has a clear vision to transform itself into a holistic multidisciplinary institution as guided by the affiliating University i.e. Dibrugarh University, Assam. The institution has been already following CBCS system under Dibrugarh University. Along with the CBCS curriculum, the institution is planning to conduct some project works on community-based Education, Environmental Education and Value-based education to impart knowledge about the said issues. As per plan for following a multidisciplinary flexible curriculum, the institution is ready to go forward in accordance with University guideline. In the context of multidisciplinary/interdisciplinary curriculum no

such remarkable efforts have been initiated so far.

However, we have a clear vision to initiate some projects on educational issues by some departments throughout the year. It is worth mentioning that we have skill based students and there is enormous possibility to undertake a handful of projects on Medicinal plant gardening. Short term courses on Eco-tourism can be introduced in near future. The institution has a plan to constitute a committee to engage itself in more multidisciplinary initiatives to find solutions to the challenging and pressing issue of the society. 2. Academic bank of credits (ABC): Being an affiliated College under Dibrugarh University, Melamora College follows the rules and regulations framed by the affiliating University from time to time. As such, the College has neither registered at NAD nor at Academic bank credits (ABC). However, the College appreciates and welcomes the concept of the ABC and wishes to adopt the same in coming years as per NEP 2020 whenever adopted by the affiliating University in the forthcoming sessions. Till then, the College has motivated its benefits of credit transfer under present CBCS system. Students to register themselves at ABC so that they can avail the benefits of credit transfer under the present CBCS system. 3. Skill development: The College has introduced four numbers of Add-on courses i.e. Spoken English, Yoga and Meditation, Tourism in North East India and Human Right in India for skill development of the students. Moreover, skill enhancement courses like Library and information science, Travel and Tourism, Communicative English, Communicative Assamese have been offering for skill-enhancement, employability to create 'Atmanirbhar citizens'. The institution recognizes the importance of vocational and career oriented education for the selfemployment of the student. Introduction of vocational courses are included in College perspective plan as short term goal of the institution. 4. Appropriate integration of Indian Knowledge The curricular in the CBCS syllabus incorporates system (teaching in Indian Language, culture, using papers on Ancient and Modern Indian Political online course): Thought, Indian Classical Literature and Modern Indian Literature, Indian Philosophy etc. to instill a sense of rootedness and pride among the students regarding rich traditions of Indian knowledge system.

	The use of Assamese language as a major mode of communication in the classroom except English enables the native learners to understand the topics clearly. In the Social Science subjects, Assamese is a medium of instruction in the examinations. The College conducts workshops, Add-on course and Yoga programmes.
5. Focus on Outcome based education (OBE):	After attaining autonomy, curriculum will be redesigned with greater emphasis on Outcome Based education (OBE). Introduction of additional vocational course in each semester with focus on OBE is planned. Workshops and faculty Development programs on development of materials for OBE will be conducted. Regular assessment of the course-based students' feedback will be institutionalized.
6. Distance education/online education:	The College will start two centres for distance education Krishna Kanta Handique State Open University (KKHSOU) which operates the undergraduate course and the Dibrugarh University Open Learning (DDOL) Centre for postgraduate courses in near future.

1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Melamora College is affiliated to Dibrugarh University and the entire course curriculum for degree programme is designed by the University. The planning and documentation is done accordingly.

Prospectus: Melamora College prepares its prospectus. All the information related to curriculum delivery is included in this prospectus.

Academic Calendar: Melamora College prepares and follows an Academic Calendar based on the Dibrugarh University Academic Calendar. All the important dates related to curriculum delivery, admission, Sessional examination, field tour, seminar, group discussion, examination form fill up, final examination, IA marks notification, result declaration etc. are included in the Academic Calendar. It includes major programmes and activities to be organized by the College.

Class Routine: The Academic Council prepares the central class routines considering the syllabus. The departments prepare the Departmental Class Routines and allot classes to the teachers based on the central routine. During the lockdown period, a flexible routine was followed so that students can attend the online classes conveniently.

Orientation: The College organizes orientation programme for the students. The Principal, Vice Principal, IQAC Co-ordinator and HoDs of the departments and teachers oriented the students about the course, syllabus, different facilities in the College and rules and regulations.

Teaching Plan: Departments prepares semester wise teaching plans for the courses. HoDs monitor the implementation of these.

Online Classes: To ensure effective curriculum delivery during the lockdown period, or during restrictions for physical classes, notified for online classes. Teachers also used free versions of online conference platforms like Zoom, Whatsapp etc. Online class practices are continued even after lockdown period, to complete the courses on time.

Tutorial and Remedial Classes: College ensures effective delivery of curriculum by conducting Tutorial and Remedial classes.

Assessment and Result: The Examination Committee plans and conducts the Sessional and End semester examinations of the Dibrugarh University. The end semester examination results are declared by the University.

Feedback: College takes and analyses feedback from the stakeholders.

Student centric methods such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences.

The College provides teaching methodologies which focuses on imparting education through a student centric approach. The aim of this approach is to make student active learners instead of passive recipients and to boost their confidence level. Teachers allow students to directly involve in class activities so that they can absorb and grasp information at their own pace.

Course objectives and programme outcomes are clearly defined in syllabus for giving opportunity of self-evaluation and to understand the primary focus of the course.

Teachers make classes as interesting as possible and encourage innovative thoughts and novel interpretation. Smart classroom, Google meet, seminar, workshop etc. are some of the means utilized by the departments to provide experiential and participative learning. Written assignments are required to be submitted by the students for enhancing self-confidence and writing skill. Moreover, these methods help students to overcome the stage of fear and develop oratory power. The project and field work help students to acquire experiential learning and problem solving abilities. Discussion and debates, quizzes etc. help students to acquire problem solving ability. Generic Elective and skill Enhancement courses offered to prepare the students for life. Opportunities are given to form Students union and participation in decision making process. They are also encouraged to participate in the different social issues and problems of neighboring communities. Some other student centric methods are as follows-

Seminar presentation, assignments, essay competition, field study, educational tour, practical work of education department, personal counseling, organization of sports, culture etc., extension activities, yoga training, departmental activities, mentoring students etc.

Teachers use ICT enable tools for effective teaching-learning process.

Use of ICT tools in teaching-learning process is a demand of the situation. As a consequence, teachers are combining technology with traditional mode of instruction to engage students in long term learning. The teachers of Melamora College use online educational resources, social networking sites, blended learning platform like Google classroom to effectively deliver teaching and provide enhanced learning experience to the students. Teachers prepare modules on important topics which are produced and reproduced and make available to the students for the creation of a student centric approach. You tube, Emails, WhatsApp group, Zoom, Google meet etc. are used to communicate and provide online learning materials to the students. Student can download their syllabus and CBCS course structure from the College website. WI FI facility, smart classroom, projector is available in the College premises. 2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Melamora College follows the rules and regulations laid down by Dibrugarh University for internal and external (End semester) assessment. 20 marks in each paper taught by the College are earmarked for internal assessment score. This 20 mark is divided as follows-

10 marks- For two Sessional examinations, 5 marks for Home Assignment, Group Discussion, seminar, Field study. 5 marks for Attendance.

The Sessional examinations are conducted either by the internal Exam. Committee or by the concerned Departments. Dates of the Sessional Examinations are fixed in compliance with the Academic Calendar of the University. The setting of question paper, invigilation duty and evaluation of answer scripts for each paper are done by the concerned teacher(s) as a part of their normal duty. The notices of the Sessional Examination are displayed in the Notice Boards, Website and shared in instant messaging groups well in advance for the information of the students. The examinations are conducted in hall with strict compliance to the rules and regulations of the University. A student who has less than 80% attendance in average is not to be permitted to sit for the End (external) semester examinations.

Mechanism of External Assessment:

External assessment or End Semester Examinations are conducted as per the schedule prepared by Dibrugarh University. Examination schedules are published in advance and as per the Academic Calendar. Practical Examinations for Education Department are held by the College and notices for external examinations with practical examinations are issued well in advance.

The Principal acts as the Officer in-Charge for external examination. Vice Principal is assigned as the Assistant Officer in-charge. One faculty for each semester with non-teaching staff is assigned as Examination In-charge. The faculties are appointed as invigilators for the examinations.

The faculties of the institution also participate in the evaluation system of the affiliating University as examiners.

Grievance redressal system for Internal Assessment:

The Departments of the College maintains a thoroughly transparent mechanism during the evaluation process for internal assessment.

However, if any student in any capacity is not satisfied the way the examination was conducted, the answer scripts were evaluated, or the scores were assigned, he/she may contact the faculty concerned for that particular examination. If the faculty believes that the grievance expressed by the student is legitimate, then it is rectified immediately. If the grievance is of complex nature or cannot be resolved immediately, then it is deferred to the Head of the concerned Department. If the Head is unable to resolve it, then it is forwarded to the Principal. The decision of the Principal in terms of the grievance is final and binding.

Grievance redressal system for external assessment:

There is no re-evaluation system for external or end semester examination. However, a student can appeal for re-scrutiny after taking due approval from the Principal.

Organizational structure of the College is planned according to the guidelines of the DHE, Govt. of Assam. However, the College has introduced its own mechanism of governance by inclusion of Academic Vice-Principal and IQAC Co-ordinator for smooth functioning. It helps in planning of Academic activities like admission, examinations, and results and facilitates the coordination between HODs and the Office of the Principal. The College Librarian is assisted by Assistant Librarian and the Library Assistant and Library Bearer. College office is headed by Senior Assistants and they are helped by Junior Assistants and Gradeiv employees.

Governing Body is the main decision taking body of the institution. It consists of a president, Principal (Secretary), the vice-Principal (ex-officio member), the Librarian, two University nominees, two teacher representatives, one office representative, three guardian members including one women member, one donor member, local M.L.A as invitee member, respectively. President of the Governing Body is appointed for 5 years. All major decisions including appointment of staff are taken by the Governing Body.

Principal is the administrative head of the institution, conducts day to day activities as per UGC and DHE, Assam guidelines. He is assisted in all activities by Vice Principal, faculty members and non-teaching staff.

IQAC takes various initiatives for quality enhancement, prepares and implements policy taking for quality enhancement.

Librarian involves in the administration of and supervises the day-to-day activities of the College library.

For the smooth conduct of academic, administrative and other activities, the College authority has constituted different **Committees**, **Cells and units**.

The services of the employees are regulated as per provincialisation of College Employees Act and College services conduct rule.

The service rules, recruitment and promotional policies are followed in accordance with the regulations of the UGC as well as the state government.

A Perspective Plan of the College has been prepared for 5 years which includes both short-term and long-term goals and effort is made to ensure that the plans are fulfilled. 6.4 Financial Management and Resource Mobilization

Response:

The College has a determination to grow and for this purpose, it requires sufficient fund and needs to identify its sources of fund and to widen the resource base for attainment of its determination to grow. Some of the sources of fund are Students' Fee, fund received from Govt. of Assam. To meet its growing requirement, the institution has no sufficient fund. Taking into account limitation of the institution to

mobilize sufficient fund from its internal sources, efforts are made to mobilize fund from external sources like Local M.L.A and from the Corporate Body like Numaligarh Refinary Limited. Proposals for fund have already been submitted.

All fees collected by the College administration are deposited under the respective heads of accounts through bank challans.

To look after all construction related works, the College has formed a construction Committee. The plans and estimates of the constructions are prepared by the appointed Engineer by the College.

Similarly, to ensure transparency in financial transaction, the College emphasizes on internal and external audit of fund and submits utilization to the funding authorities within time limit. The College stresses on online financial transaction as far as possible. The College uses Online Software of Affiliating University at the time of admission and in respect of salary the College uses FINASSAM of Govt. of Assam.

The institution conducts external audits regularly. It has conducted audit up to the current financial year. External sources of fund of the institution comprise of Scholarship from state government and other funds from government. Internal sources of fund comprise tuition fee, library fee, examination fee, center fee, Students' union body fee, etc. The entire fund received from external and internal sources are audited by a Chartered Accountant. All the statements relating to income and expenditure along with supporting documents are submitted to the Chartered Accountant who prepares Utilization Certificate and income expenditure statement. After receipt of Audit Report, it is placed before G.B of the College for consideration.

It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

The IQAC has contributed significantly for institutionalizing the quality assurance strategy and system.

The College aims at continuous improvement of quality for achieving academic and administrative exCellence. For this purpose, the College set up IQAC in the year 2016. It is reconstructed in the year 2021 as per NAAC new guideline. Since its inception, the IQAC has been continuously trying to develop a system of conscious, consistent and catalyst improvement in the overall performance of the institution. Moreover, it also tries to promote measures for institutional functioning towards quality enhancement

through internationalization of quality culture and institutionalization of best practices. In this regard, the IQAC prepares strategies and processes from time to time which are as follows-

- The IQAC encourages the faculty members to enhance their teaching skills by participating in FIP/FDP, Refresher course, workshop, seminar, research, publications etc.
- The IQAC encourages the departments to organize departmental seminars, workshop, group discussion, field trip, educational tour, Quiz etc.
- The IQAC works for the coordination and integration of various Cells and Committees.
- The IQAC motivates the departments to keep the records of courses, class tests, internal assessment, co-curricular activities.
- The IQAC organizes mental health and hygiene programme, cleanliness programmes, plantation, vaccination camps, awareness programme etc. to involve the students in the different issues of neighbouring society.
- The IQAC promotes teachers to use ICT tools and conduct academic audit.
- The IQAC emphasizes on timely conduct of academic and administrative activities.
- The IQAC motivates the teaching and non-teaching staff for the NAAC process.

The IQAC has devised several mechanisms to review the effectiveness of the teaching learning process. It has adopted a number of quality strategies to make the overall teaching -learning experience more interesting, absorbing and student-centric. These academic, administrative and infrastructural strategies include encouraging the students to use ICT in seminar presentations, increasing the number of books in the library, procurement of equipment in the laboratory of education department, classroom teaching supplemented with field studies, educational tours, introducing awards for teachers, students and officials, development of the mentoring system that promotes interactions between the student and the faculty members, etc. Class tests are taken by the respective departments to assess the students. The class test and Sessional examinations help the students in preparing themselves for the Final Exam. thoroughly. Orientation programmes are regularly organized to orient the students about the courses, syllabus, examination, different facilities and rules and regulations, code of conduct etc. The IQAC asks all the departments at the beginning of the academic session to submit their teaching plan. The IQAC Coordinator along with the Vice Principal looks after all these affairs and act accordingly. It has introduced Departmental Audit system as an internal academic audit mechanism to make the teaching, learning and evaluation system more effective.

Moreover, the IQAC generates feedbacks from different stakeholders. Feedback on academic performance, evaluation system and teachers' quality are collected from students. The feedbacks given by the students are assessed and submitted to the head of the institution for placing them in the Governing Body for discussion and necessary actions are taken for incremental improvement.

For them secondary education completion means academic education finished. Some of them even do not know about higher education. To make them conscious about the benefit of higher education, Melamora College takes initiative to aware them about it. Through the counseling in adopted village the institution emphasizes the importance of higher education. The College has planned to adopt more villages in near future so that the ignorance could be vanished from their minds. In this away the campaign of Indian Govt. comes true through initiative taken by the institution.

Women Cell is very active in this regard. Various eminent women personalities are invited for the guidance on social issues on the occasion of International Women's Day. Health and hygiene programs are organized. Anti-sexual harassment Committee and Internal Complain Committee have been keeping a strong eye regarding the protection of girl students.
